Scholarship Award Details

- **Value:** \$500 per recipient
- **Use of Funds:** May be applied toward **conference registration** and/or **hotel accommodations**
(Note: Travel expenses are not covered)
- **Total Awards Available:** Up to **10 scholarships** will be awarded
- **Selection Method:** NSPMA is committed to equitable access and professional growth for all school facility professionals. All completed applications will be entered into a **lottery drawing**. To ensure scholarships reach those most in need, applicants must demonstrate that their school, district, or organization faces significant financial constraints and that without this support, attendance would not be possible.

Eligibility Requirements

To be considered for the NSPMA 2026 Attendee Scholarship, applicants must:

1. Be employed by a public school, district, or related public educational agency
2. Not have received a prior NSPMA grant or scholarship
3. Submit a complete application, including:
 - A Letter of Support from a public school employer
 - A Statement of Financial Need from the employer or applicant
 - i. Budget constraints within the school, district, or organization
 - ii. Lack of available professional development or travel funding
 - iii. How this scholarship would enable attendance and benefit professional growth
4. Submit the application **by Wednesday January 14, 2026**
